#### 5. ITEM(S) OF BUSINESS

## • Willow Street and Virginia Drive Property:

Attorney Ben Harding mailed letters to the property owner and concerned neighbors of the Willow Street and Virginia Drive property, updating them about the decision and actions by the Board of Commissioners at the July 1, 2019, Regular Meeting. Attorney Harding encouraged both the property owner and concerned neighbors to attend the Planning Board meeting in August, along with the Board of Commissioners meeting in September to express any concerns or comments regarding the proposed revisions to the Ordinance in regard to Outdoor Recreation Facilities. Mayor Norman led a short discussion with the Board of Commissioners to establish if anyone had any concerns or questions regarding the letters sent by Attorney Harding. The Board of Commissioners concurred, they were all in agreement with the current proposal.

#### • Employee Insurance:

Mayor Norman asked Finance Officer Dina Reavis to give the Board of Commissioners a quick background on the history of the proposed insurance plan. Finance Officer Dina Reavis explained that Chad Huff with Allegacy contacted her in June letting her know that The League of Municipalities had quoted our exact same insurance policy we currently have at a cheaper premium. This plan would be HSA eligible. Our present insurance plan through Blue Cross and Blue Shield is a grandfathered plan. After some additional discussion among the Board regarding yearly increases, retiree options, HSA eligibility, and employee concerns it was the consensus of the Board to keep the existing insurance plan we have at this time.

#### 6. ADJOURNMENT

With no further business to discuss, Commissioner Chris Matthews moved the meeting be adjourned. Commissioner Tony Hall seconded the motion, and the motion was approved unanimously. The meeting adjourned at approximately 9:14 a.m.
